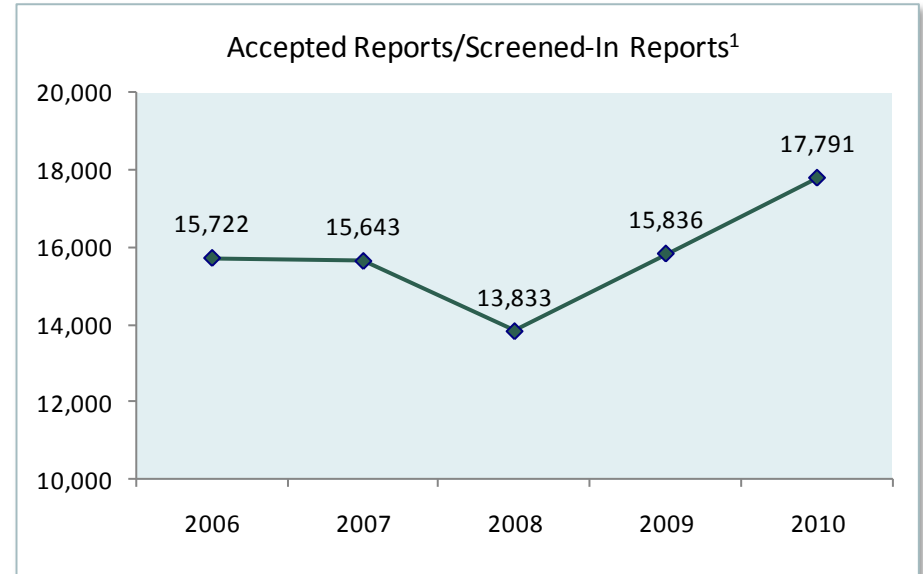
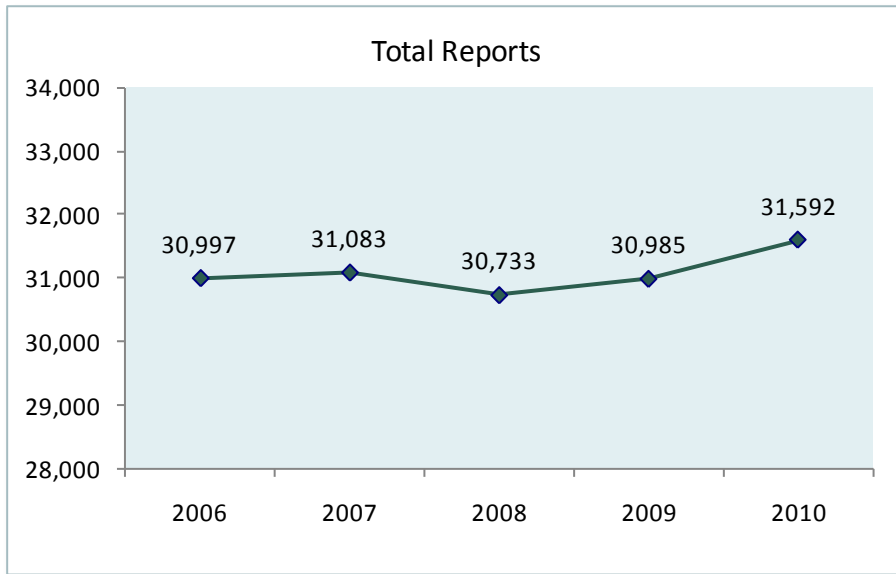

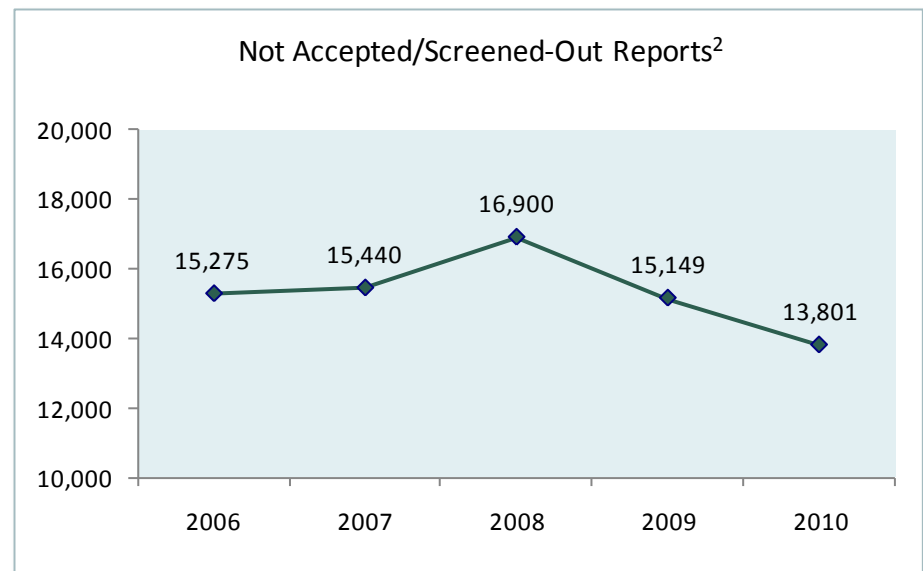


1. A screening determination on an incoming report is made by State Central Intake (SCI). Once accepted, the PS report is assigned to the appropriate county office for investigation.

2. Reasons for non-acceptance of a report may include:

- No specific allegation/risk of abuse/neglect,
- Insufficient information to investigate,
- Referral to another agency,
- Does not meet sufficiency screening criteria,
- Perpetrator is non-caretaker/out-of-home,
- Referral to law enforcement, and/or
- Duplicate reports.

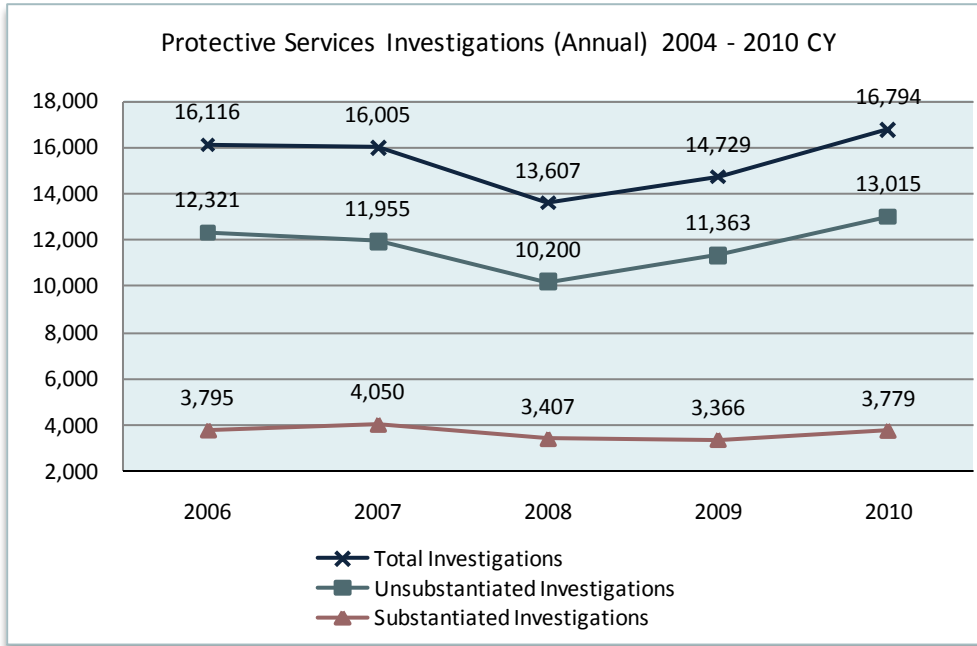

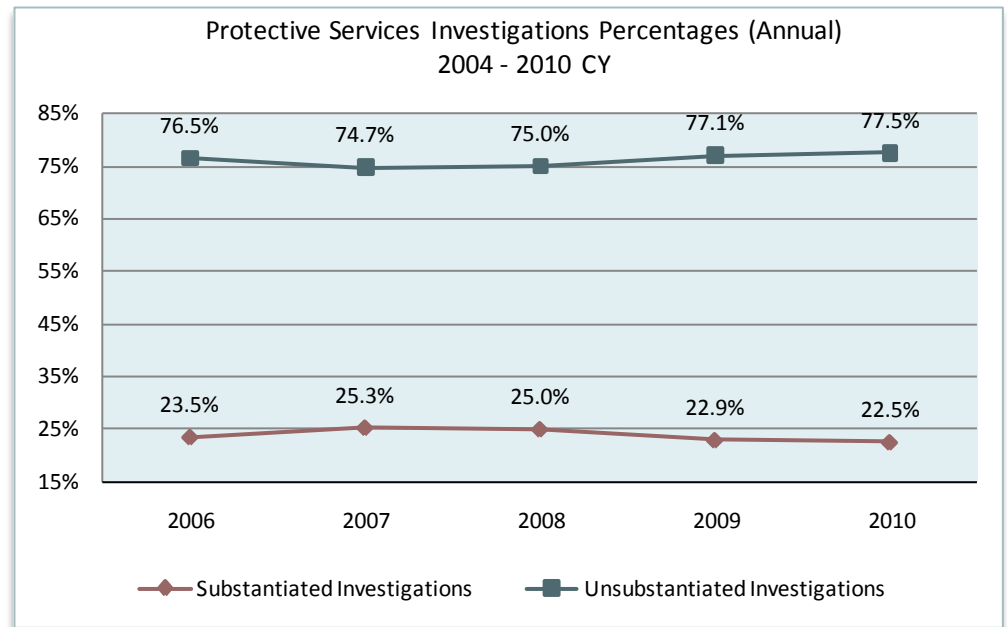

3. **“Substantiated”** in a child abuse and/or neglect investigation means the victim(s) is under the age of 18, a parent/caretaker has been identified as the perpetrator and/or identified as failing to protect, and credible evidence exists to support the conclusion by the investigation worker that the child has been abused and/or neglected as defined by the New Mexico Children’s Code.

4. **“Unsubstantiated”** means that the information collected during the investigation does not support a finding that the child was abused and/or neglected as defined by the New Mexico Children’s Code.

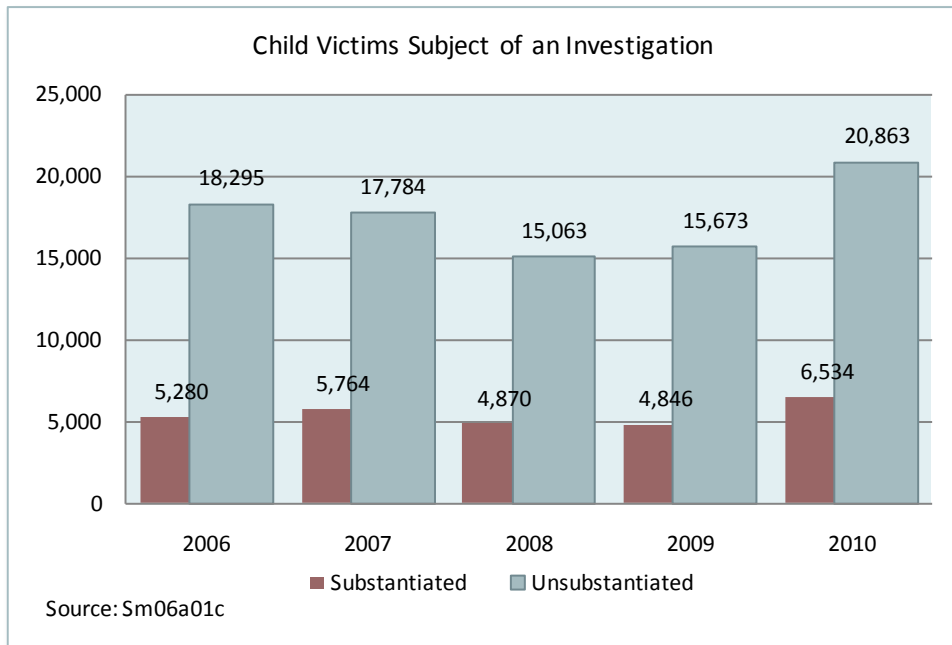

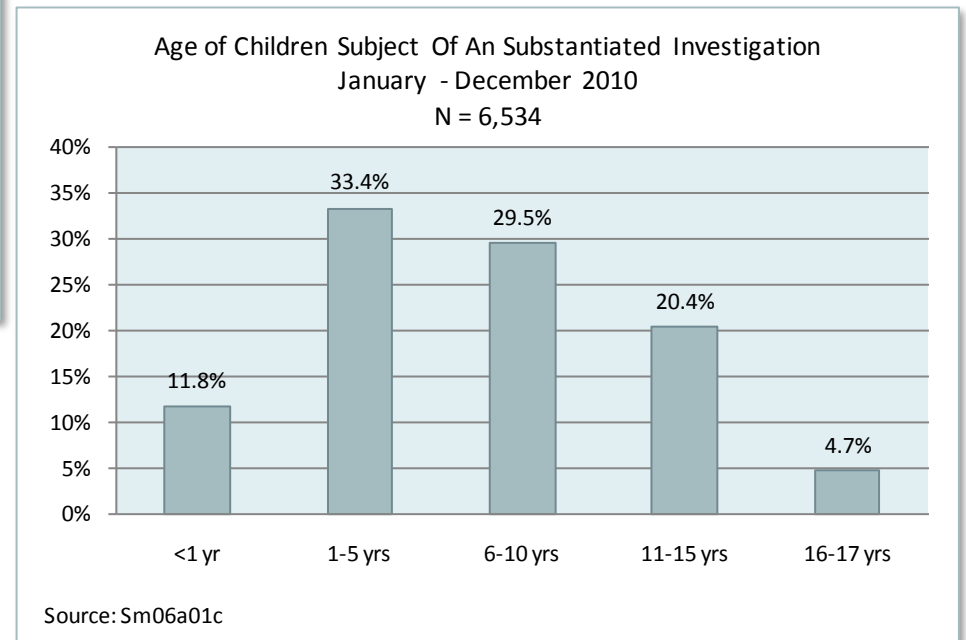
The age category "Other" is comprised of children whom, at the time of the PS report/referral, the recorder did **not** have specific information related to the children's age.

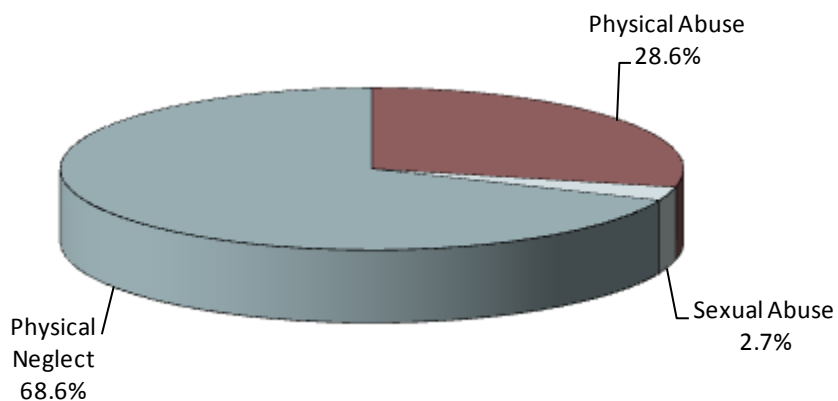

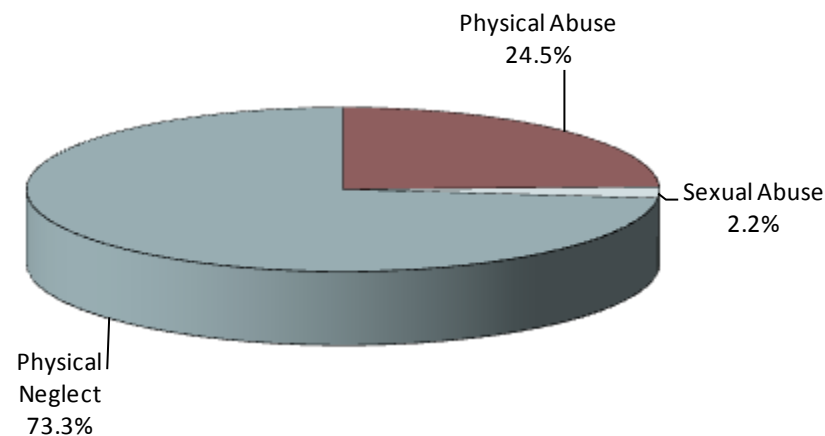

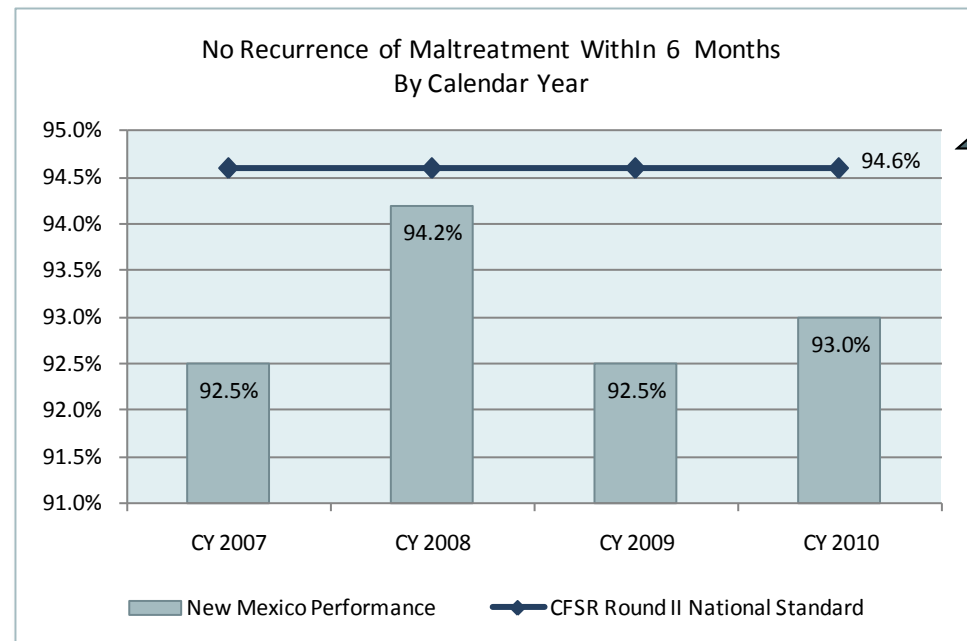

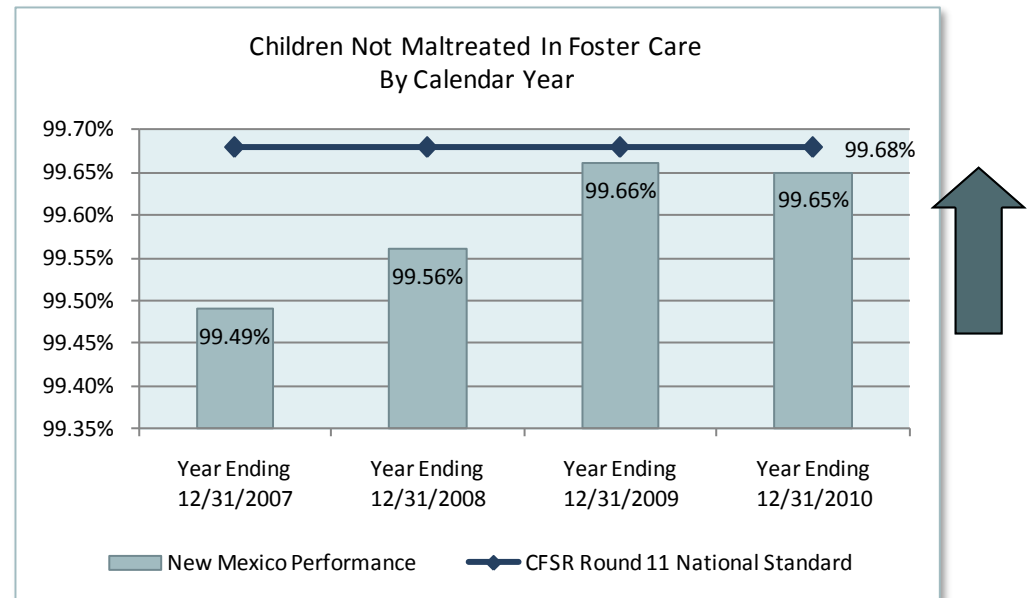

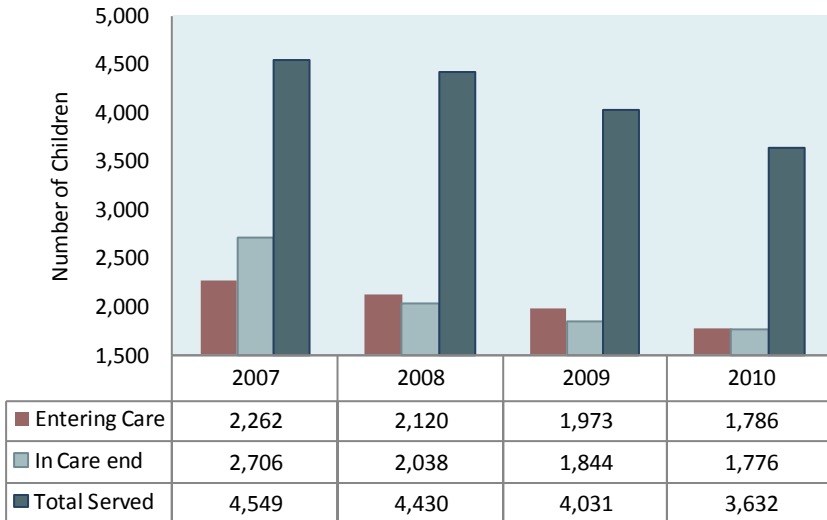

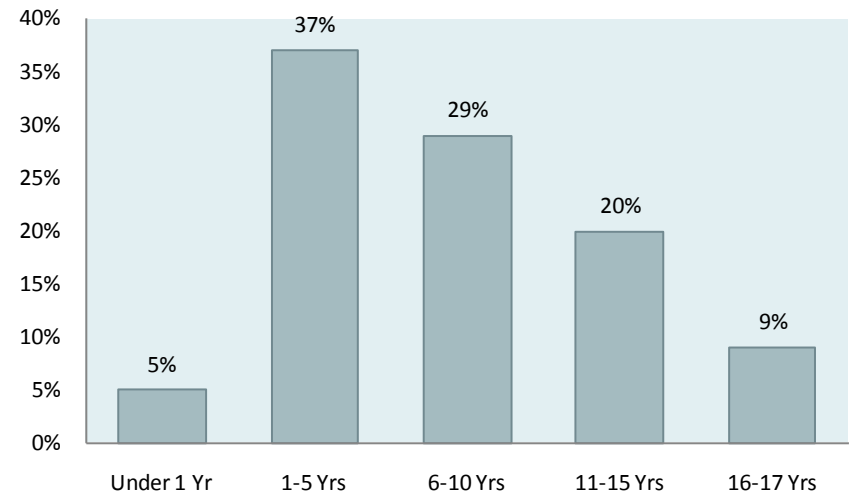

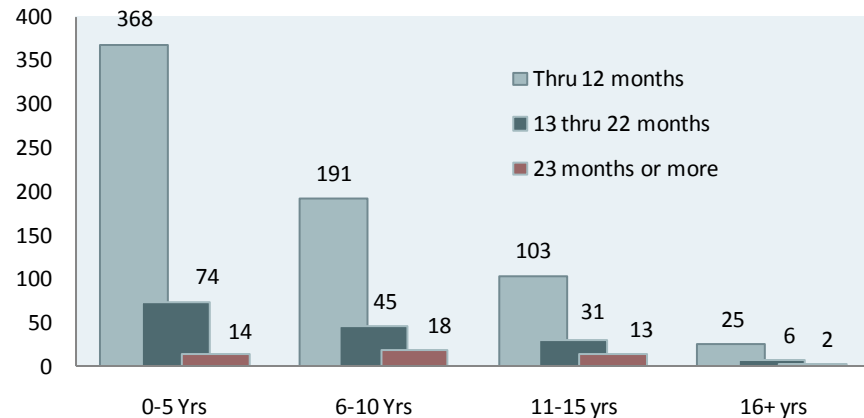

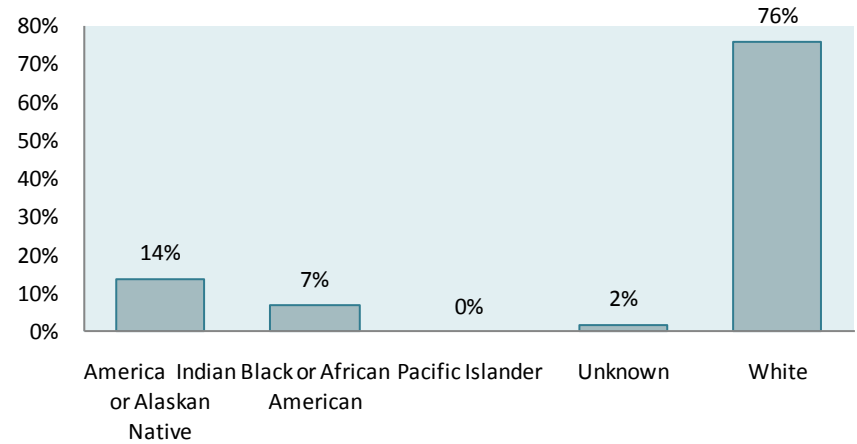

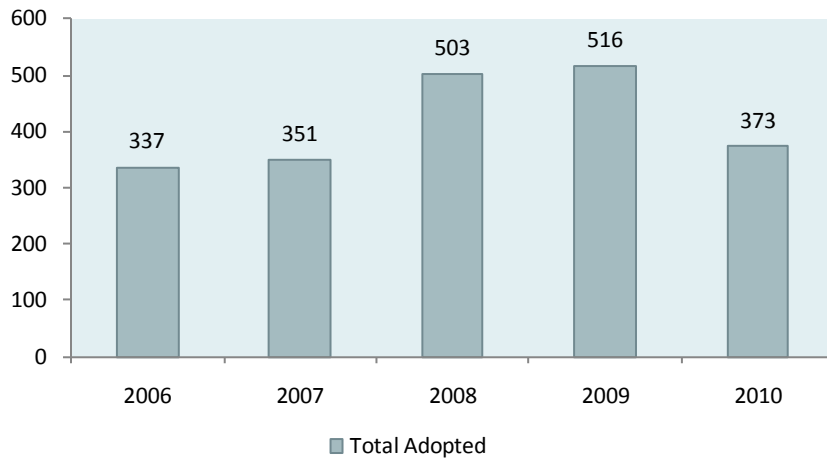

January 1, 2010 - December 31, 2010



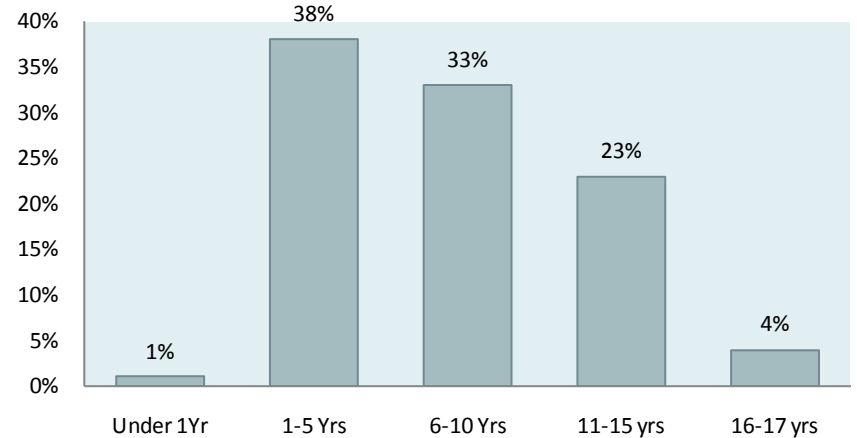

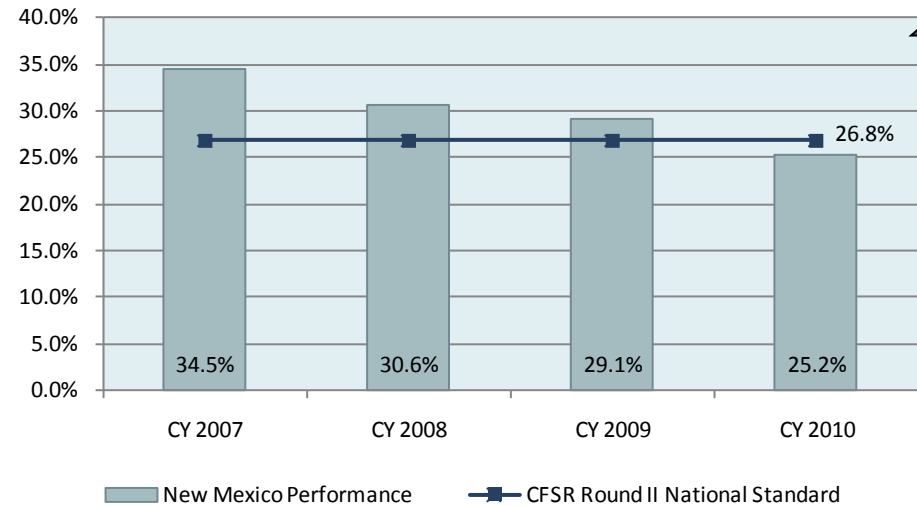

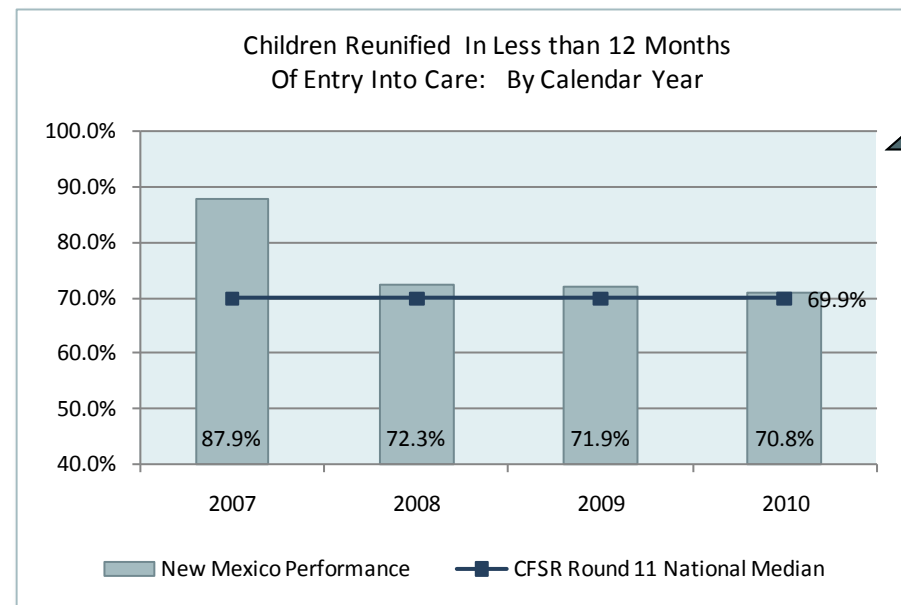

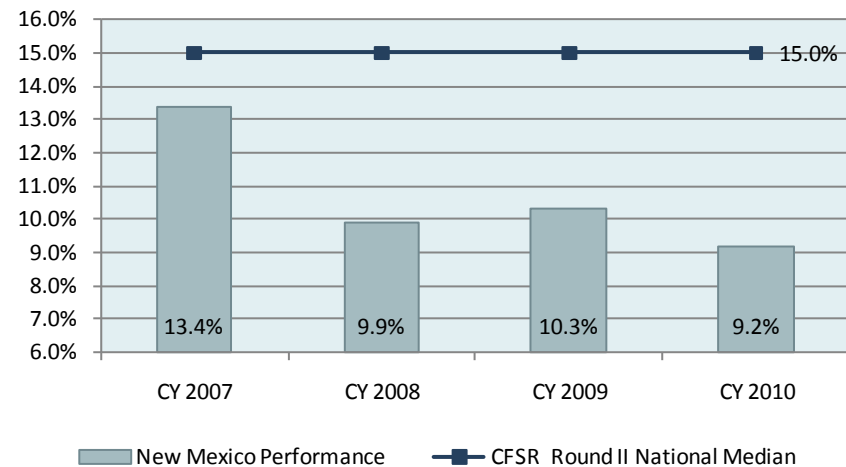

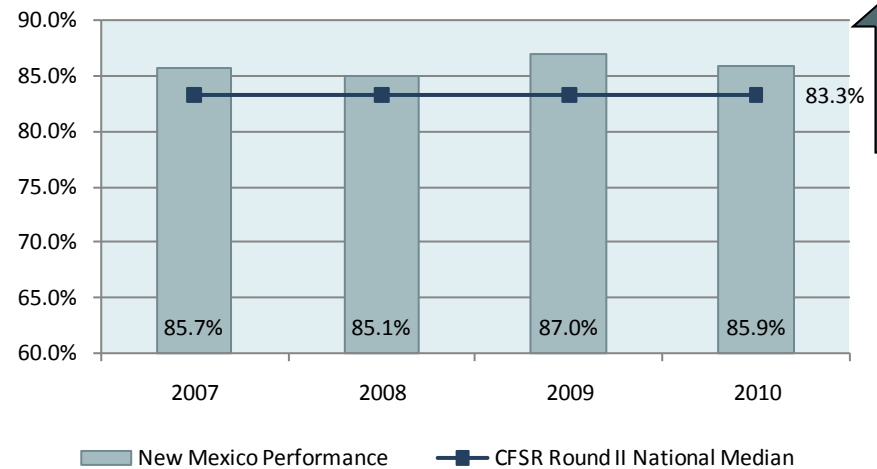

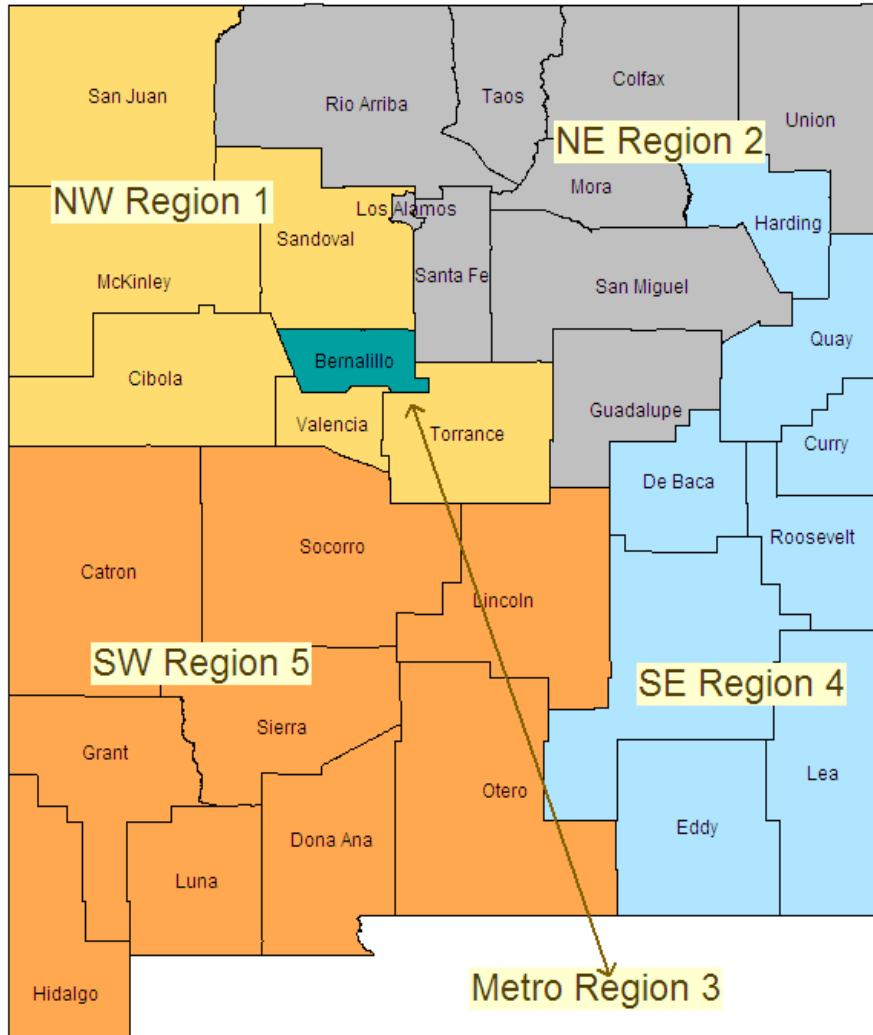

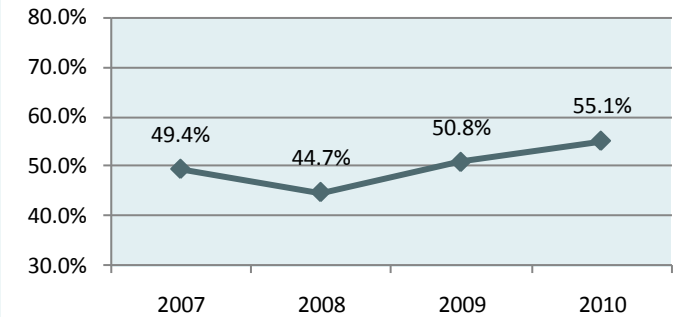

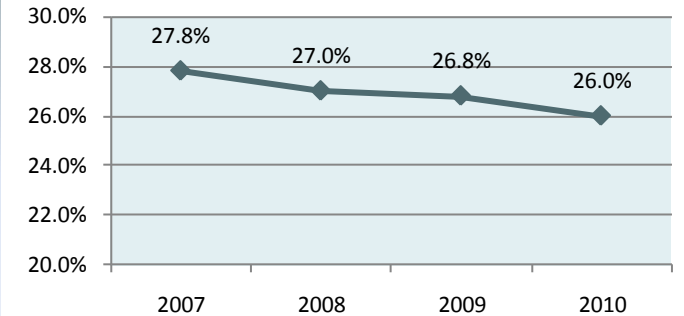
Percent of Accepted Reports of Abuse and Neglect

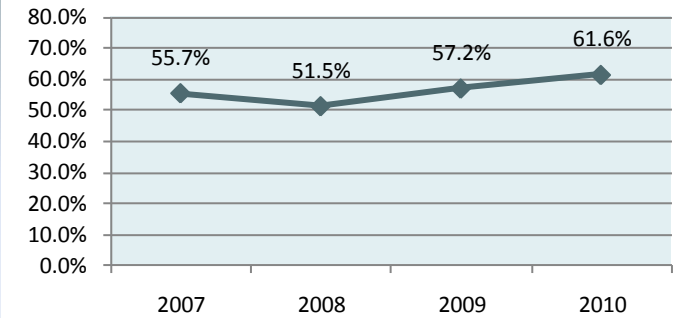

Percent of Accepted Reports of Abuse and Neglect



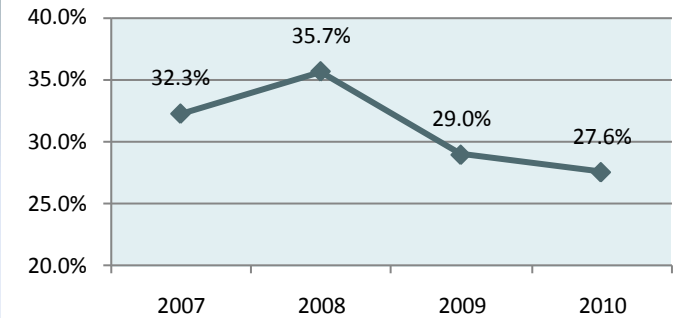

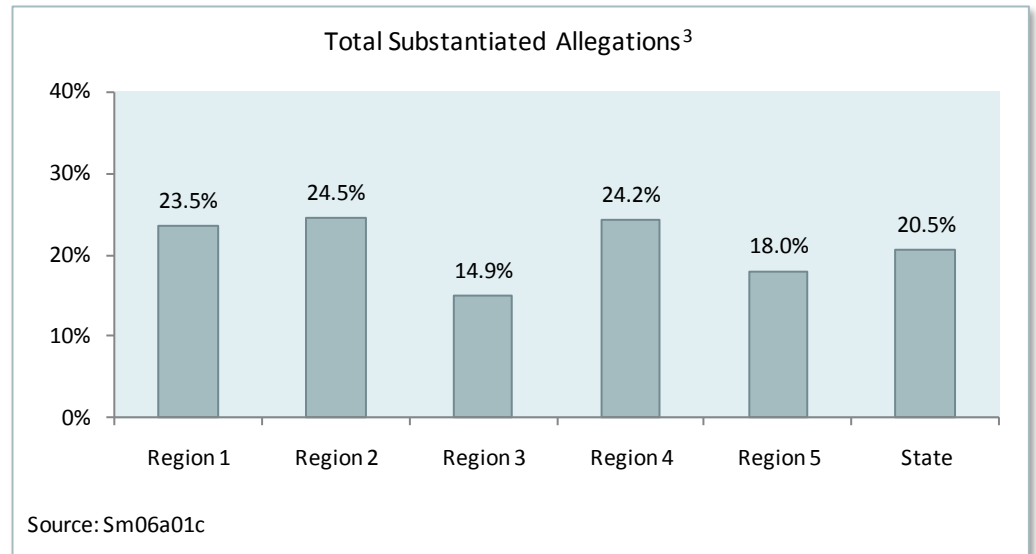

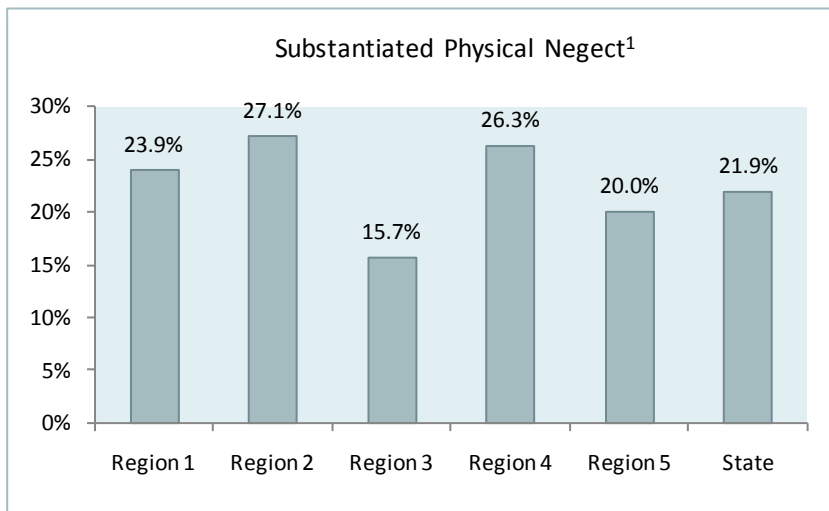
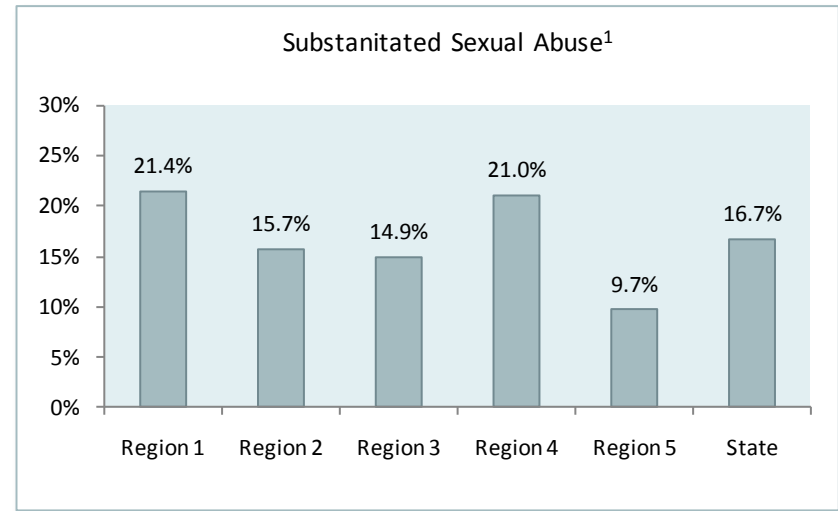
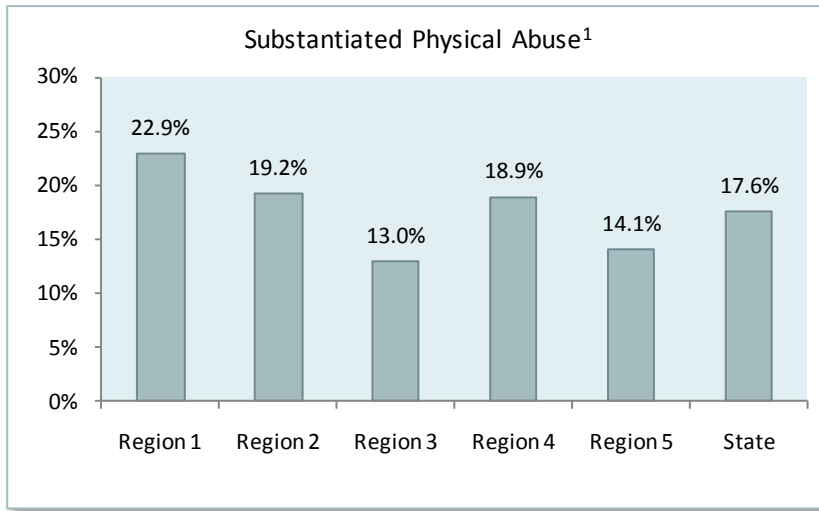

JANUARY – DECEMBER 2010



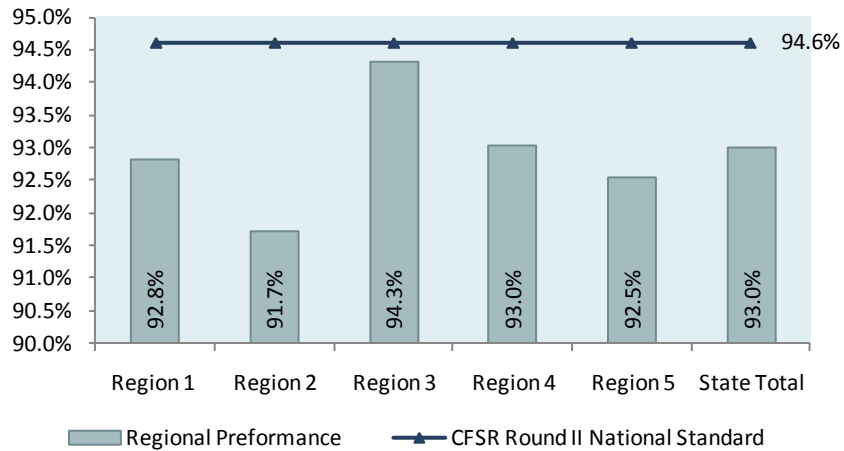

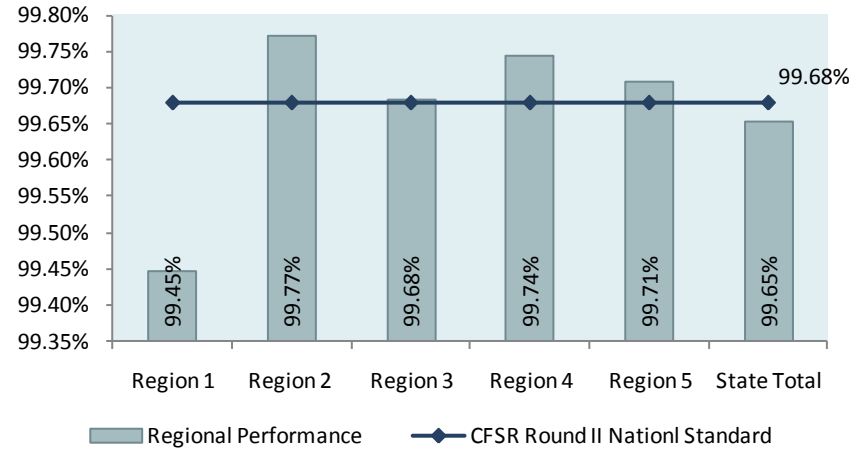
REGIONAL COMPARISON¹ - PERCENT OF STATEWIDE TOTALS

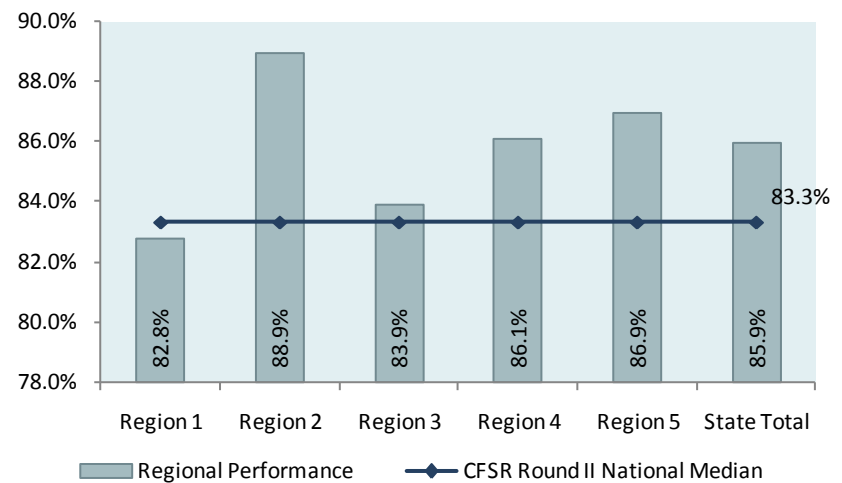
Children Without a Recurrence of Maltreatment within 6 months of a Previously Substantiated Report of Maltreatment¹

Children In Care for Up To 12 Months with No More Than 2 Placement¹

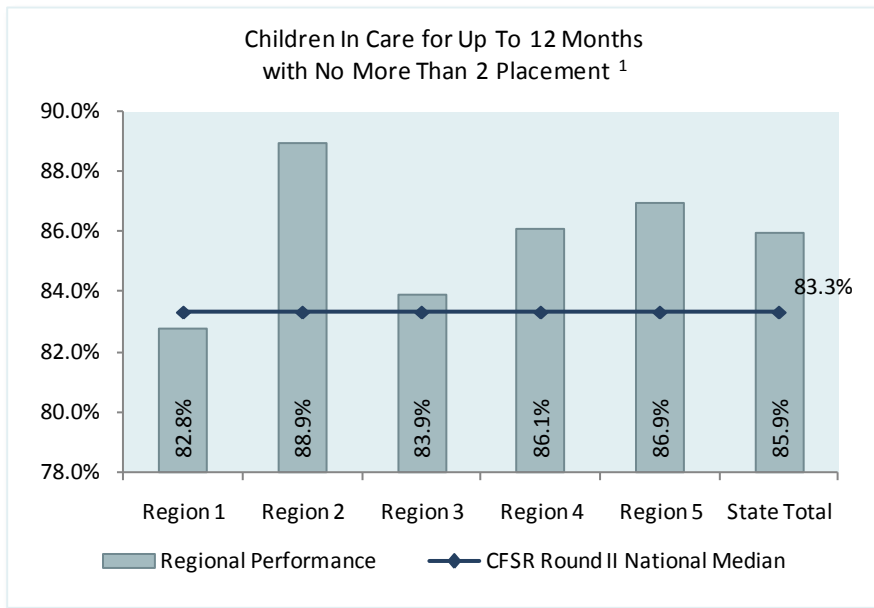
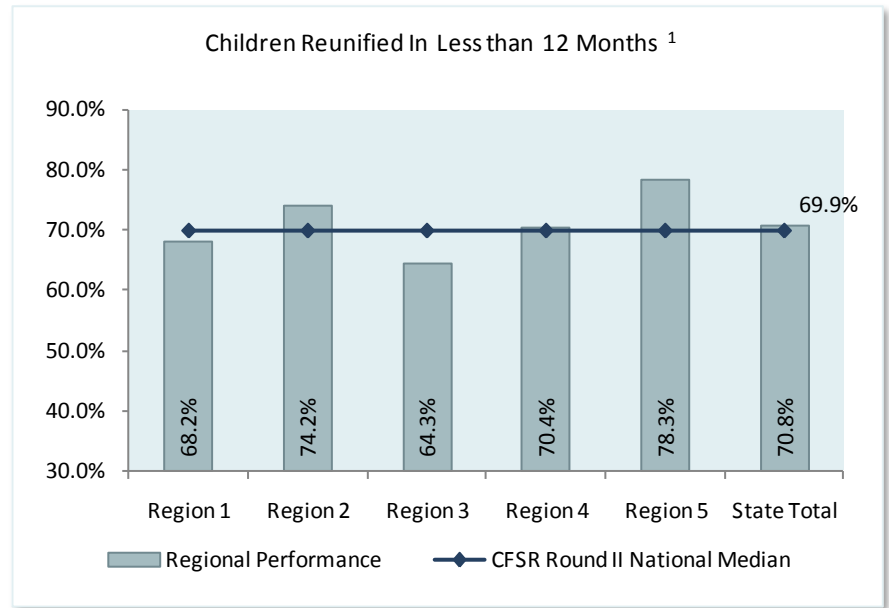
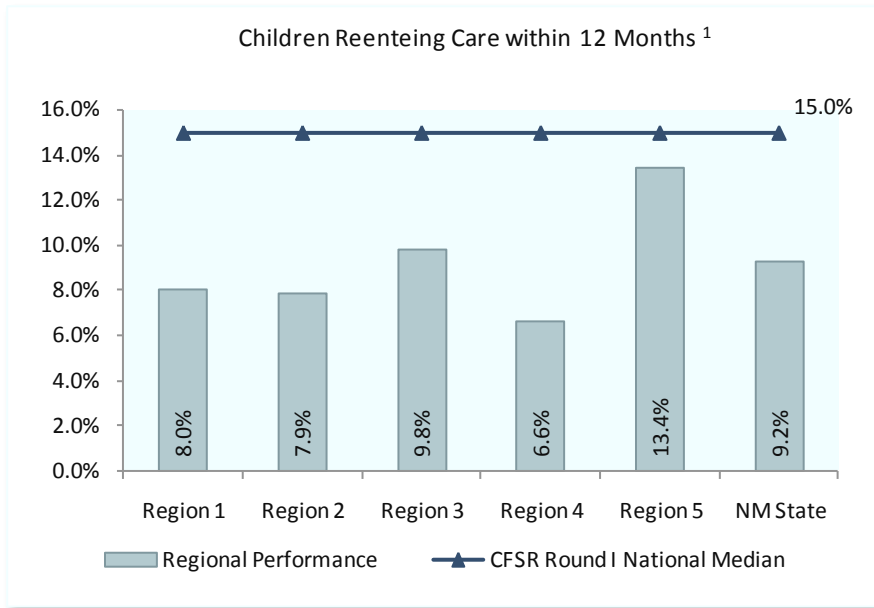
