Eligibility

ELIGIBLE CHILD CARE PROFESSIONALS

- Child Care professionals employed with a licensed or registered provider
- Eligible and up-to-date background check with ECECD Background Unit
 - Includes all employees such as cooks, bus drivers and administrative staff

NON-ELIGIBLE PROFESSIONALS

- Home Visitors
- Early Intervention
- Public Education Department (PED) programs



Application Overview

To complete the application, you will need the following on file with ECECD's Background Check Unit:

- SSN or ITIN
- Name
- Mailing Address
- Phone Number

You will also need to provide:

- Employment Information
 - Start date
 - Job title
 - Years worked in early child care and education programs

Note: If awarded incentive pay, some of the information submitted on this application will be used by ECECD to create a W-9 form.





Awards and Payment

Incentive payments will be issued starting in mid-November:

- Payment will be issued via paper check and sent to mailing address indicated on the application
- Home providers will receive payments via direct deposit or paper check depending on your current financial information on record in EPICS
- Awardees will be issued a 1099 and be responsible for paying all local, state and federal taxes.
