# FY25 General Fund Increase by Program Area

### Child Care (\$75,000.0)

- Maintain expanded eligibility
- Expand access to high-quality child care for infants and toddlers through contracted slots
- Increase staffing for Child Care Services Bureau (9 FTEs)

#### Program Support (\$658.8)

- Enhance data systems for nutrition and child care services
- Improve security compliance and reduce agency risk (2 FTEs for security compliance)
- Convert two TERM positions to ensure continuity of Human Resources and Information Technology services

### **New Mexico PreK** (\$33,000.0)

 Serve up to 2,700 additional children in PreK and Early PreK

#### **Quality Initiatives** (\$30,000.0)

- Conduct research-based assessments, enhance coaching, professional development, technical assistance for child care (FOCUS Redesign)
- Increase PreK coaching and professional development on early literacy and social and emotional development
- Invest in a wage and career ladder for infant and toddler teachers and assistant teachers
