INTRODUCTION

The New Mexico Early Childhood Education and Care Department (ECECD), through the Family Nutrition Bureau (FNB), is excited to announce grant funding for the New Mexico Grown (NM Grown) grant for organizations participating in the Child and Adult Care Food Program (CACFP). This funding is available to organizations who meet certain eligibility criteria, including participation in the Child and Adult Care Food Program (CACFP), and wish to purchase foods grown, raised, harvested, or processed in New Mexico to serve to their children.

PURPOSE

ECECD is expanding the NM Grown grant program to organizations participating in, or eligible to participate in, the Child & Adult Care Food Program because it is critical to engage and improve the health and nutrition outcomes of children and adults in New Mexico. The purpose of this funding is to provide eligible organizations participating in CACFP with the opportunity to purchase food grown, raised, or harvested in New Mexico. This opportunity will foster a connection between ECECD organizations and local farmers and ranchers so that local foods can become staples for young children across New Mexico.

ELIGIBILITY

The application is open to organizations participating in, and in good standing* with, the Child and Adult Care Food Program (CACFP). This includes the following types of organizations:

- Child Care Centers, PreK programs, and all Head Start/Early Head Start programs which selfprepare CACFP meals on site.
- Licensed Adult Day Care facilities, At-Risk Afterschool programs, Emergency Shelters, & Out of

School Time programs

This funding is not open to home-based childcare providers currently. *Must be in good standing with CACFP, with no serious deficiencies nor unresolved correct actions.

FUNDING

- Total Funding Available: \$300,000.00
- Minimum grant request: \$1,000 for a 12-month period
- CACFP providers may, and are encouraged to, request the amount of funds for a 12-month period they deem necessary to purchase the desired quantity of New Mexico Grown products based on the number of children they serve.
- Funding will be dispersed according to the size of the organization.
 - **Small organizations** (less than 5,000 meals/snacks served per month) are eligible for \$1,000 to \$5,000*.
 - **Medium sized organizations** (greater than 5,000 but less than 10,000 meals/snacks served per month) are eligible for up to \$5,000- \$10,000*.
 - Larger organizations (more than 10,000 meals/snacks served per month) are eligible for up to \$25,000*.
- The amount awarded will be based on the justification of the amount requested and rationale outlined in the organization's purchasing plan regarding whether these costs are reasonable, and the number and size of requests received as compared to the funding that is available.

*These funds are based on current funding; these amounts may change based on available appropriations.

ALLOWABLE USE OF FUNDS

The funding is solely for the purchase of products that are grown, raised, harvested or produced in New Mexico. Products must be purchased from suppliers off the Approved Suppliers List. Allowable products that may be purchased with this funding include, but are not limited to:

- Vegetables and/or fruits
- Herbs
- Honey
- Grains and/or flour
- Traditional foods (e.g., corn meal including blue corn mush and atole, chicos, hominy, etc.)
- Chile
- Plant-based proteins (e.g., beans, tofu, seeds, nuts)
- USDA inspected and certified meat products (beef, pork, bison, lamb/mutton)
 - Only 40% of award funding may be spent on meat products

The Family Nutrition Bureau will work with providers to expand the list of products deemed allowable throughout the duration of the grant, and specific guidance on allowable New Mexico products will be provided in award letters.

REIMBURSEMENT

This funding is based on reimbursement. Grantees are expected to spend money out-of-pocket to make allowable purchases, then must submit receipts to ECECD by email for reimbursement. Grantees will be reimbursed through standard mechanisms established by the Family Nutrition Bureau. Grantees will be expected to email completed **purchase log(s)** and **receipts or invoices** to ECECD Family Nutrition Bureau (FNB) fiscal manager and food security coordinator, for approval of reimbursements by the 15th of each month, or more frequently. ECECD will then process payments to the grantees through EPICS.

All invoices and purchase logs are due to ECECD no later than May 30, 2025.

More information on purchase tracking and reimbursement will be provided in the email sent out with the award letter.

PRIORITY FUNDING CRITERIA

Applications will be evaluated according to the following criteria:

- 1) **Purpose and Goals.** A short statement explaining the purpose and objective for applying for the New Mexico Grown Grant. (See questions beginning on page 7)
- 2) Purchasing/Action plan. A purchasing plan that explains the grant amount requested, and the types of New Mexico foods the grantee would like to purchase. Applications that discuss the purchase of local items throughout the year-in both warm and cold-weather months-will receive better evaluations. The proposed plan should include details about any existing relationships or potential vendors the program already works with and any established effort to purchase New Mexico products.
- 3) **Participation in Promotional Activities.** Included in the application should be a commitment to participate in at least 3 promotional programming activities, such as family engagement, participation in NM Grown Week, "Nuevo Thursdays", and Golden Chile awards.

DESCRIPTION OF EVALUATION CRITERIA:

Does Not meet Expectations: This means the applicant omitted a very large portion of the requested information, failed to provide information, provided inaccurate information, or provided information that is hard to understand.

Meets Expectations: The applicant provides general but sufficient detail, and adequately addresses the criteria questions; however, some areas are not fully explained and/or questions remain for the Family Nutrition Bureau. In addition, the application may have some minor inconsistencies and weaknesses.

Exceeds Expectations: The applicant provided specific and comprehensive information and provided completed and clearly articulated responses to address the questions. The descriptions are detailed and the ideas are fully developed.

MANDATORY CONDITIONS:

All successful applications shall assure the Family Nutrition Bureau in writing that:

- 1) Food purchased is "local" as defined in this Grant Application;
- 2) Food is purchased from vendors on the ECECD "Approved Supplier Program List," (provided in the application) which certifies that the product originated on New Mexico farms that practice sound foods safety standards;
- 3) Local food purchases will be integrated into the organization's Child and Adult Care Food Program;
- 4) Invoices for reimbursement will be submitted alongside the required purchase log sheet on a regular basis and in a timely manner; and

5) Invoices will include the name of the approved supplier (vendor), name of produce, volume purchased, price, and any other details required by the FNB.

DEFINITIONS:

- "Local": Grown, raised and/or harvested within the geographic boundaries of the State of New Mexico.
- "Fresh": Unprocessed or minimally processed.
- "**Product**" / "**Produce**": The yield of a vegetable or fruit crop; meat that is harvested, or other nonproduce item that is grown, raised or harvested in NM.
- "Recently harvested": Perishables are delivered within 48 hours of being harvested to the distribution warehouse or to school site.
- "Minimally processed" means, a product that is frozen, dried, or ground/milled.
- "Nuevo Thursdays" means, an activity of trying a new fruit or vegetable every Thursday.
- "New Mexico Golden Chile Award" means, an annual award to programs that engage in NM Grown local food purchasing. Programs must apply for the award.
- "New Mexico Grown Week" means, the event every fall where programs celebrate using New Mexico grown agricultural products to foster healthy childcare nutrition and expand NM growers' ability to keep their production local.
- "GAP Certified": Good Agricultural Practices (GAP) is a voluntary certification program which verifies, through an independent third party audit, that sound food safety practices are being used on a farm or product handling facility.
