- Set rates at the true cost of care for child care, home visiting, NM PreK, and Family Infant Toddler (FIT)





- \$4.8 million for Home Visiting
- \$4.7 million for FIT Medicaid state match
- **\$3 million** for Tribal Investment Strategy
- **\$2.5 million** for Educator Incentives
- **\$2 million** for Local Early Childhood Coalitions
- **\$.5 million** for Dolly Parton's Imagination Library
- **\$4 million** for Operational Support

By not supporting the child care quality pilot program, the entry level wage for child care providers would remain at \$15 per hour instead of the proposed \$18. This would also affect teacher-to-child ratios and, ECECD would be unable to better support children with special needs.


### Executive and Legislative Finance Committee (LFC) Differences

**Without supplemental funding** the agency will not be able to pay FIT providers for their services to the state's infants and toddlers with developmental delays and disabilities. Current projections show the agency exhausting it available funding by March 2025 due to the increased number of eligible children served. In thousands




### **Projected Services and Eligibility** Child Care for Infants and Toddlers, FY25 and FY26

### **Projected Services and Eligibility** Home Visiting, FY25 and FY26


