Proposed Provider ENHANCED Rates

The enhanced reimbursement rate is available to providers that meet two conditions:

- 1. Pay all education and care entry-level employees a basic wage floor, according to the provider's level of quality, AND
- 2. Offer care ten hours a day, five days a week

Enhanced rates are available to all licensed providers, regardless of quality level.

Wrap-around care placement provides extended child care hours for children enrolled in Head Start, New Mexico PreK, and school-age programs—covering time beyond the regular school day. To make sure families have consistent coverage, the department uses a cost model that calculates care for the full year—not just the school-year calendar. This means parents and guardians working full-time can rely on child care even during school breaks or holidays. With a year-round placement agreement, families avoid gaps in care and enjoy uninterrupted service and payments throughout their approved eligibility period.

Part-time placement offers child care support for families who need fewer than 29 hours of care per week. This option is ideal when:

- A single provider cannot meet all of a child's care needs
- Families require care from multiple providers
- Care is needed for specific purposes or limited schedules
- The provider's business hours total less than 29 hours weekly

This flexible arrangement helps families access the right level of care without committing to a full-time schedule.

The department pays a differential rate equivalent to five percent, ten percent or fifteen percent of the applicable full-time/part-time rate to providers who provide care during non-traditional hours. Non-traditional care will be paid according to the following tables:
