1.	As it is written, only FOCUS programs can apply and not accredited centers? Are accredited centers being excluded from this opportunity? As the Offeror know, Christina Kent is the oldest licensed center in NM, and we serve a demographic that primarily falls below 200% of poverty and communities that are underserved - which is why we opened new classrooms.	This program is designed for currently licensed child care providers, with at least a 3-star FOCUS rating (including 5-star rated providers through ECECD national accreditation), and Nations, Pueblos, and Tribes (NPTs) who are willing to participate in the FOCUS rating program. Providers who have a 5-star rating through one of the seven ECECD approved National Accreditation bodies, as listed in regulations, are deemed to have met the requirement of equivalent of FOCUS 5-star for this purpose.

7.	Is a program allowed to apply for only infants (6 weeks to 23 months) and the rest of the classrooms for toddlers (2 and 3 year olds) remain at the licensing standards?	Providers can apply for one or both age groups. For continuity of care, it is recommended to consider both Infant and Toddler slots to account for children remaining covered for this specialized program until the child turns 36 months. The RFP evaluation will consider each program's Transition Planning – specifically, how the organization supports children as they move across age groups. (please see Section IV(A)(19) of the RFP)
8.	Are programs allowed to pick which classrooms they want to apply, if they have multiple infant and toddler classrooms in the same facility? How would that work when the children turn 2 and this grant states they must remain in the program until they transition into NM Early PreK?	Yes, providers can pick which classrooms would be best to accommodate these contracted slots. Child care providers have the option to create and plan for transitions, based on what works for their center and families. Please keep in mind when planning for slots, any classrooms that contain a contracted slot child will need to adhere to the specific ratios, group size and regulations. No, contracted slots may not be moved between infant and toddler categories during the contract term. Contracted providers must indicate the proposed number of infants and toddlers to be served in APPENDIX D. BUDGET.

(a) The maximum amount of time a family can remain presumptively eligible is 90 days. Families are expected to apply through "Am I Eligible" within 30 days of enrollment with a contracted provider. (b) If a child is deemed ineligible in Phase 2, the contracted provider will be notified by ECECD and provider must begin disenrollment process. ECECD will close the contracted slot 14 days from notification date. (c) Yes, contracted providers will receive training on the program requirements upon receiving award.
13. How does this affect children that do not meet the 200% level currently in our care? It says we can not displace or disenroll? What do we do with them?	Children whose families are above the 200% FPL are welcome to stay in the facility under a private pay slot or child care placement agreement, as space allows. If families start under a presumptive eligibility and then when they apply for full eligibility, they do not met the 200% FPL, these children will need to exit the contracted slot and will need to be transferred to a private pay spot, child care placement agreement or other program. Presumptive eligibility will give the provider a first glimpse or idea if the family might not be eligible and should not be enrolled under a contracted slot.
14. What evidence will we need to provide showing the disability?	Children with disabilities or medical conditions may have several acceptable forms of documentation. Acceptable documents include but are not limited to: Physician written authorization, Individualized Family Service Plan (IFSP) / Individualized Education Plan (IEP), Therapy Referrals, etc.
